For tank-mixes of more than two products which are not specifically listed, only what is known about the products when in two-way mix is shown, users must make their own judgment about the more complicated mixes which they may choose to use at their own risk. Similarly, a number of products are shown which have been replaced by more recent formulations for which tests have not been carried out. However the information is included for the user to draw their own conclusions.

Important Note: tank-mixes should only be made within the label recommendations of every product in the application.

Where listed for physical and biological compatibility, crops are listed as specified: **ww - winter wheat; wb - winter barley; wo - winter oats; sb - spring barley**

Where partner manufacturer specifically excludes a tank mix on specific crop, Dow AgroSciences will not support crop safety. E.g. Ally Max SX is not supported for crop safety on oats in tank mixes.

\* Nevada can be sequenced or tank mixed with other florasulam products provided the maximum dose of florasulam does not exceed 7.5 g.a.i/ha of which no more than 3.75 g.a.i/ha is applied before 1st February.
